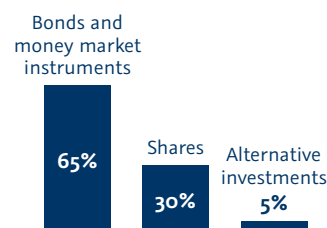
### POSSIBLE RETURN
